



# COVID-19 Policies

Updated: August 23<sup>rd</sup>,2021

Due to the COVID-19 pandemic we have new policies at Kinderwood. Upon arrival an office personal will take your child's temperature. If your child is scanning in at **99.9** or more, they will not be able to attend. If a student develops 1 or more symptoms of COVID-19 they will be sent home and **cannot return until symptom free for 72 hrs.** In some cases, we require a doctor's note explaining the symptoms or a COVID-19 test. Anyone who enters the building must wear a mask and all visitors must fill out our COVID questioner. **We are only allowing one parent down the hall for pick-up and drop off. All siblings must wait in office. This is because they are returning back to school and coming in contact with other people that hasn't been fully vaccinated. We are highly suggesting that the same parent does drop off and pick-up. Parents are NOT allowed to enter the classrooms or playgrounds. Parents must stay in main hallway or by playground doors at pick-up or drop-off. If you or a family member has received a COVID vaccine, please leave a copy with office. All staff members are required to always wear a face mask. We ask that all families be truthful and forthcoming if a possible exposure or symptoms of COVID-19. If your family goes on a vacation, we request a COVID test 3 days after returning from trip. If your child has no fever but is requiring 1 on 1 care, Kinderwood will ask to be picked up.**

## What are the drop-off procedures?

1. When you arrive at Kinderwood you will see red dots in front of the door. These are 6ft markers for appropriate social distancing. Please stay on the markers until the person in front of you has completely left their marker.
2. Once you are in the Lobby you will either use your own pen or use hand sanitizer and the school pen to sign your child in. Kinderwood is allowing 5 families in at a time. **All siblings are to be left in office. We are currently only allowing 1 parent to drop off and pick up at a time.**
3. An office personnel will do a temperature scan and a visual wellness check of your child(ren).
4. You will then walk your child(ren) to the classroom door or playground door.
5. You will leave and have a great day.

## What are the pick-up procedures?

1. When you arrive at Kinderwood you will see red dots in front of the door. These are 6ft markers for appropriate social distancing. Please stay on the markers until the person in front of you has completely left their marker.
2. **Once you are in the lobby you will either use your own pen or use hand sanitizer and the school pen to sign your child(ren) out. Please leave all siblings in the office .**
3. You will pick up your child (ren) from their classroom or playground door. We are currently only allowing 5 families down the hall for pick-up.
4. You and your children will leave and have a happy evening.

**Classroom Procedures:** In the classroom, children are split in small groups. The groups will rotate from outside to inside. Groups will not exceed 12:1 in rooms 3,4, and 5 ratio and 4:1 ratio in rooms 1 and 2. When napping, students are napping 6 ft apart in a head-to-toe layout. After every nap time each mat is wiped down with a disinfectant wipe. Each classroom is section off to practice social distancing. Each section will have a day where it is open and closed to students. After students are done playing with toys they are disinfected in a bleach and water solution. At the end of the day the last teacher in the room will spray everything with a disinfectant spray. All surfaces will be thoroughly cleaned with disinfectant before and after each day, according to the manufacturer's directions. All common surfaces are disinfected more than 3 times a day. At the end of the day, a professional cleaner cleans the entire school after we close.

## Covid-19 Testing:

Staff is required to get a Covid-19 test bi- weekly if not fully vaccinated. Kinderwood may ask for **ALL** members in household for a COVID test when child is exhibiting 1 or more symptoms.
